DECLARATION OF DEBRA CHIYA IN SUPPORT OF TEMPORARY RESTRAINING ORDER

## I, DEBRA CHIYA, declare as follows:

- I am an adult and I have personal knowledge of the facts set forth herein, and if called as a witness, I could and would competently testify thereto, as to those facts which I declare on information and belief, I believe them to be true.
- 2. I am the duly elected Treasurer of the Anaheim Japanese Free Methodist Church a California Nonprofit Religious Corporation, also known as Anaheim Free Methodist Church (AFMC) from the year 2002 to the present. I make this declaration in support of the Plaintiffs' Application for Temporary Restraining Order.
- 3. Since 2002, as the Treasurer, I have personal knowledge of how the financial business of the AMFC is managed, including, the creation of budgets by the local AFMC Board, approval of budgets by the Society membership, management of bank accounts, payroll of employees, payment of building maintenance and repair, payment of real estate taxes and payroll taxes, and health insurance.
- 4. The Anaheim Japanese Free Methodist Church has a separate Employer Tax Identification Number (EIN) for payment of payroll taxes in its corporate name.
- 5. Since 2002, I have been listed as the corporate treasurer with the California Secretary of State's annual information statement. Officers of the local Board have been listed as the corporate officers with the State of California. [A true and correct copy of the May 28, 2020 and most recent statement of information are attached as (Exhibit 1 & 2).]
- 6. Since 2002, the Pacific Coast Japanese Conference has never approved any of the AFMC's financial business, itemized above. All business, including the bank accounts have been managed under the local church's Board of Directors, and members.
- 7. AFMC has consistently paid for the support of Pacific Coast Japanese Conference by paying the Conference a stated percentage of monthly donations, currently set at six-point-eight-percent (6.8%) of the donations received from members of the AMFC.
  - 8. From my personal experience, the Pacific Coast Japanese Conference

appoints the lead pastor to AFMC, however, the local Board of AFMC approves the salary, and is responsible for payment of pastoral benefits including life, and disability insurance premiums, medical, dental and vision insurance, pension contributions to a plan managed by the Free Methodist Church of North America.

- 9. From my personal experience, in over twenty (20) years, the Pacific Coast Japanese Conference has <u>never</u> asserted the power to act as the Board of Directors for the Anaheim Japanese Free Methodist Church, a California nonprofit corporation, and it has never acted as the Board of Directors of AFMC.
- 10. I was told by the recently appointed pastor that I was being fired effective April 30, 2023, and I was directed to hand over control of the AFMC bank accounts and financial records to the Voice Church of Orange County, Inc.'s personnel and third-party bookkeeping vendors.
- 11. On Friday April 28, 2023, I received a copy of a letter from the PCJC's attorney Brad Greenman from the Tyler Law LLP law firm, stating that I was in breach of trust to the Conference if I did not turn over control of the AFMC bank accounts to the Voice Church of Orange County, Inc.
- 12. I request that the Court place a hold on any changes that have been communicated to me by PCJC and Voice Church of Orange County, Inc. until this Court can declare what is legal. I want to follow the lawful process.

  I declare under penalty of perjury that the foregoing is true and correct.
