- 4. Since that day, I have been emotionally distraught at losing our identity as

  talked to have said the same.

  17 sometimes up to three times a day, when I think about our loss, I have become nauseated
  18 and feel ill.
- 19 6. I feel that April 30, 2023, was our last Sunday and we can't meet as the20 Anaheim Free Methodist Church anymore. This is very troubling to my mind and spirit.
- 7. I ask that this Court grant a Temporary Restraining Order to keep things as
  they have been for the past fifty years that I have been attending the Anaheim Free
  Methodist Church, until it can determine how the law applies to this takeover.
